













This guidance document has been produced by the Green Social Prescribing Project, a partnership between Energize Shropshire, Telford and Wrekin and Shropshire Wildlife Trust, with support from both local authorities.

There are many groups and organisations across Shropshire, Telford and Wrekin offering activities that take place in our beautiful green and blue spaces. For example, gardening groups, walking groups, walking football, croquet clubs, paddleboard clubs and conservation groups.

These groups do a great job of encouraging people to get outside and take part in low levels of activity whilst socialising. There is a real need for more people to benefit.

If your group has talked about expanding and helping others enjoy our green spaces, you might want to consider becoming a green social prescribing intervention. This guidance will show you how to do that.

# What is Social Prescribing and Green Social Prescribing?

Social Prescribing is like a prescription for medicine but is a non-clinical approach.

Social Prescribers are available through GP surgeries to explore issues that are negatively affecting patients' physical and mental health and overall well-being.

Social Prescribers connect people to activities, groups and services in their community to meet the practical, social and emotional needs that affect their health and well-being.

Green Social Prescribing refers people to local, non-clinical, nature-based outdoor activities to help improve their physical and mental health.

The National Association of Social Prescribing outlines the benefits in their evidence briefing:

### Social Prescribing: the natural environment.

Nature-based social prescribing activities can positively impact happiness and well-being. This can be by reducing social isolation and developing a connection to nature, particularly in people who may be experiencing health inequalities. Both contact and connection with nature play a role in improving health and well-being outcomes.

Social prescribing interventions are schemes/activities which are usually provided by voluntary and community sector organisations.

Any community group or organisation can become an approved activity and receive referrals from the Social Prescribing Link Workers/Healthy Lives Advisers.

Alternatively, you can list your group/organisation in a directory as this will let people know who you are and how they can contact you directly.

# Which area is your group based in - Shropshire, Telford and Wrekin or both?

Social prescribing is done slightly differently in Shropshire than in Telford and Wrekin, so you will need to follow the route relevant to where you are based/deliver activities.

# **Shropshire Local Authority Area**

In the Shropshire Council Area, the Social Prescribing Link Workers are known as **Healthy Lives Advisers**.

Here you can

- 1. Become a Quality Assured Green Social Prescribing Intervention.
- 2. Become an organisation that clients are signposted to rather than referred in to, by being added to the Shropshire Directory.

To become a Quality Assured Green Social Prescribing Intervention please contact one of the four **Community Development Officers** who will support you through the process.

Once you are a fully constituted group/organisation your Community Development Officer will complete a Quality Assurance Process and sign you off as a Green Social Prescribing Intervention.

You will have the opportunity to join the Community Connectors Virtual Network which is an e-Bulletin sent to the community and voluntary sector and other partners.

### **Telford and Wrekin Local Authority Area**

In Telford and Wrekin, The Social Prescribing Link Workers are known as Social Prescribers.
